

PRIVACY POLICY

The aim of the Privacy Policy is assist you with understanding how AdMine collects, uses and discloses the information users' provide when accessing or using the website admine.io.

COLLECTED INFORMATION

On AdMine website you may provide us with two types of information: personal information that you voluntarily disclose; and information collected automatically when you use AdMine website or the services available on AdMine Website (collectively, the "Information").

PERSONAL INFORMATION

Personal information is collected only when voluntarily offered and solely for purposes that are clearly identified on AdMine website. Personal information means any information that is unique to you, such as your: Name, Username, Password, E-mail address, Cryptocurrency, Address, Mailing address and other personal information you choose to provide.

By providing us with your personal information, you also consent for us to collect, hold, use and disclose your personal information in accordance with this Privacy Policy. In addition to providing the foregoing information, if you choose to correspond further with us through e-mail or through the "contact" section of AdMine Website, we may retain, use and disclose the content of your messages together with your e-mail address and our responses.

AUTOMATICALLY COLLECTED INFORMATION

When you use AdMine website or services available on AdMine website, we automatically collect information from your devices. We collect the following information:

- ***Server Log Information.*** We collect server log information when you use AdMine website, which may include (but is not limited to) your login details, the date and time of visits, the pages viewed, your IP address, time spent at our Website and the websites you visit just before and just after AdMine website.
- ***Device Information.*** We collect information about the computer or mobile device you use to access our Website, including the hardware model, operating system and version, the web browser you use, and other device identifiers.
- ***Telemetry Information*** If you use any of our open source software, we may collect bandwidth upload and download speeds, the amount of free and used storage space on your device and other statistics about your device.
- ***Usage Information*** If you use AdMine website, we will collect metadata about the files you upload for storage and we will record instances in which you have used your private key to authenticate communications.
- ***Information Collected by Cookies and Other Tracking Technologies.*** We and our service providers use various technologies to collect information when you interact with our Website, including cookies and web beacons. Cookies are small data files that are stored on your device when you visit a website, which enable us to collect information about your device identifiers, IP address, web browsers used to access the Website, pages or features viewed, time spent on pages, mobile app performance and links clicked. Web

beacons are graphic images that are placed on a website or in an email that is used to monitor the behavior of the user visiting the website or sending the email. They are often used in combination with cookies.

USE AND SHARING OF INFORMATION

The Information will be used only for:

- providing, maintaining, delivering or improving AdMine website or the products or services provided through AdMine website;
- analyzing and tracking data to determine the usefulness or popularity of certain content and to better understand the online activity of AdMine website users;
- fulfilling our legal or regulatory requirements;
- providing you with the information or products or services that you have requested;
- answering your inquiry or responding to a communication from you;
- developing new products or services;
- sending you technical notices, support or administrative notifications;
- communicating with you about news, products, services, events and other information we think will be of interest to you;
- matching your Information with job vacancies to assist us in finding a position that is most suitable for you if you have contacted us about recruitment;
- monitoring and analyzing trends, usage and activities in connection with AdMine website;
- detecting, investigating and preventing fraudulent transactions or unauthorized or illegal activities;
- protecting the rights and property of AdMine (as defined below) and others;
- linking, connecting or combining Information we collect from or about you with other Information; and
- carrying out any other purpose or reason for which the Information was collected.

The Information will be shared only in the following ways:

- with your consent or at your instruction;
- with our current or future parent companies, affiliates, subsidiaries and with other companies under common control or ownership with us or our offices internationally;
- with third parties or service providers that perform work for us;
- certain information you may choose to share may be displayed publicly, such as your username and any content you post when you use interactive areas of AdMine website like our online forums;
- in connection with a merger or sale of our company assets, or if we do a financing or are involved in an acquisition or any other situation where Information may be disclosed or transferred as one of our business assets;
- in response to a request for information if we believe disclosure is in accordance with, or required by, any applicable law, regulation or legal process;
- if we believe your actions are inconsistent with our user agreements or policies, or to protect the rights, property and safety of AdMine or others; and
- with third parties where aggregate Information is disclosed which cannot be reasonably be used to identify you.

PROTECTION OF PERSONAL INFORMATION

Reasonable steps were taken to protect the security of the information communicated through AdMine website. Nevertheless, no security system is entirely bulletproof, and does not exist a secure method for transmitting information. Thus, no responsibility lies on us for the data you submit to or receive from us through the Internet or for any unauthorized access or use of that information. We cannot and do not guarantee that information communicated by you to us or sent to you by us will be received or that it will not be altered before or after its transmission to us.

You agree to not hold us and our respective past, present and future employees, officers, directors, contractors, consultants, equity holders, suppliers, vendors, service providers, parent companies, subsidiaries, affiliates, agents, representatives, predecessors, successors and assigns (collectively, the “AdMine”) liable for any loss or damage of any sort incurred as a result of any misappropriation, interception, modification, deletion, destruction or use of information provided through our Website.

If you wish, you can easily turn off the cookies, however switching off cookies may restrict your use of our AdMine website. You may also opt out of receiving promotional communications from us at any time by following the instructions in those communications. If you opt out, we may still send you non-promotional communications, such as technical notices, support or administrative notifications or information about your account (if you have one).

Finally, AdMine website may contain links to other third-party websites that may collect personal information about you, including through cookies or other technologies. If you link to another website, you will leave AdMine website and this Privacy Policy will not apply to your use of and activity on those other websites. You should consult these other websites' privacy policies as we have no control over them and are not responsible for any information that is submitted to or collected by these third parties.

SOCIAL SHARING FEATURES

AdMine website may offer social sharing features, links to social media and other integrated tools. Your use of such features enables the sharing of information with your contacts or the public, depending on the settings you use with the entity that provides the social sharing feature or social media. Please visit the privacy policies of the entities that provide these features to obtain more information about the purpose and scope of data collection and the processing of such data by such entities.

CHANGES TO OUR PRIVACY POLICY

We may change this Privacy Policy in our sole discretion at any time. Any revisions to this Privacy Policy will be posted on the home page of AdMine website. It is your obligation to periodically visit AdMine website to review any changes that may be made to this Privacy Policy. Your continued use of AdMine website constitutes your agreement to be bound by any such changes to this Privacy Policy. If you do not agree with this Privacy Policy, you are not authorized to use AdMine website and your sole recourse is to not use AdMine website.
